



The Seminar will bring together experts from the UK and a number of International Representatives from the IEA DSM Programme to consider the challenges and opportunities that future electricity systems may face and the solutions DSM can offer.

The Seminar will consider some of the questions that have been raised in relation to the development of Demand Side Management programmes within the UK, including how DSM can be used to mitigate the impacts of inflexible generation; the interaction between DSM and Smart Grid developments; and the challenges faced in engaging small consumers in demand side programmes. This Seminar precedes the IEA DSM Executive Committee meeting which will be held in Chester on Thursday 21st and Friday 22nd October 2009. It is therefore a unique opportunity to meet some of the international thought leaders developing effective DSM programmes.
