Task I/ST8: INDEEP The international energy efficiency and demand-side management programme internet database

Objective

The objective of the INDEEP internet database is to improve the effectiveness of utility and government implementation of end-use energy efficiency programmes by providing:

- Inspiration for EE programme developers
- Comparable elements between programmes and the environments in which they were/are being implemented (i.e. key values related to target costs, and results) for programme developers, implementers and evaluators
- Contact information
- Specific information designed for use in currently deregulating environments and national EE programme evaluation

The Information

INDEEP focuses on programme descriptions and key summary data. Extra attention is given to programme goals and results with regard to programme costs, participation rates, and energy and demand savings.

Each programme is characterised by energy objectives (energy efficiency, load optimisation, fuel switching), energy sources affected, technologies, and programme type (such as general information, education, market

programme type (such as general information, education, market transformation, alternative rates). The target groups are specified as customers (residential, commercial, industrial, or agricultural) or non-customers (e.g. architects, builders, and retailers).

Marketing incentives and methods are also indicated. More qualitative information on programme results is presented as 'lessons learned' eg key elements for programme success or failure, difficulties encountered, or recommendations for programme improvement.

New Work

INDEEP is currently updating programmes (on-going and completed) and evaluation data. National Task Experts (from actively participating countries) are also collecting and processing new information with the project goal of acquiring 130 new programmes by end 2003.


